ARTICLEI NAME OF CORPORATION

The name of the corporation is the Corrente Bello Subdivision Homeowners' Association, Inc., hereafter called the "Association."

ARTICLE II REGISTERED OFFICE

The initial registered office of the Association is located at 291 E. Shore Drive, Suite 202, Eagle, Idaho 83616.

ARTICLE III REGISTERED AGENT

Todd Hill is hereby appointed the initial registered agent of this Association,

ARTICLE IV PURPOSE AND POWERS OF THE ASSOCIATION

This Association is a nonprofit corporation. The general purposes for which it is formed are to provide for maintenance, preservation and architectural control of the residential lots and common lots within that certain tract of property commonly known as the Corrente Bello Subdivision according to the plats thereof filed in the official records of Ada County, Idaho, and any additions thereto as may hereafter be brought within the jurisdiction of this Association, hereinafter called the "Property", and to promote the health, safety and welfare of the residents within the Property. Without limiting the power and authority of the Association, the Association may take any of the following actions in furthering its purposes:

- exercise all of the powers and privileges and perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions For Corrente Bella Subdivision, hereinafter called the "Declaration," applicable to the Property and recorded in the office of the Recorder, Ada County, Idaho, and as the same may be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length;
- auquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- borrow money, and, pursuant to the terms of the Declaration, mortgage, pledge, or deed in trust any or all of its real or personal property as security for money borrowed or debts incurred;
- dudicate, sell or transfer, pursuant to the terms of the Declaration, all or any part of the common lots to any public agency, authority or utility for such purposes and subject to such

conditions as may be agreed to by the members;

- participate in mergers and/or consolidations with other nunprofit corporations organized for the same purposes or annex additional residential property and common lots, provided that any such merger, consolidation or annuxation shall be in conformance with the terms of the Declaration;
- exercise any and all powers, rights and privileges which a corporation organized under the Idaho Nonprofit Corporation Act may by law now or hereafter have or exercise.

ARTICLE V MEMBERSHIP AND VOTING RIGHTS

Membership in the Association and the voting rights associated therewith shall be as enunciated in the Declaration.

ARTICLE VI BOARD OF DIRECTORS

The affairs of this Association shall be managed by a board of at least three (3) but no more than five (5) directors who need not be members of the Association. Initially, the board shall consist of three (3) directors. The number of directors may be changed by amendment of the Association's by-laws. The numes and addresses of the persons who are to act in the capacity of the directors until the selection of their

At the first annual meeting, and at all annual meetings thereafter, the members shall elect all directors for a term of one (1) year.

ARTICLE YII DISSOLUTION

The Association may be dissolved by a vote of not less than two-thirds (2/3) of each class of members at a duly noticed meeting. Upon dissolution of the Association, other than incldent to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted exclusively to such similar purposes. No part of the monies, properties or assets of the Association, upon dissolution or otherwise, shall inure to the benefit of any private person or individual or member of the Association.
